2. VG Clark Cancer Relief Trust Fund

The Judge Advocate provided a summary of the trust fund requirements. (encl 3) After a meeting with Commander Kaberides, the judge advocate, and two Frost Bank representatives, it was determined that changes to the process to disseminate the funds to veterans was urgently needed. Frost Bank's maintenance fee is \$250/ month, total \$3,000 annually. In the past three years, there have been only three (3) veterans who received money for a total of \$150.

Recommendations for changes to the process the trust fund:

- a. Change veterans suffering with cancer TO veterans with active cancer, not in remission.
- b. Change confined to any Army, Navy, or Veteran Hospital TO veterans receiving active cancer treatment as an inpatient or outpatient basis.
- c. Change to provided for minor luxuries TO for the needs of the veteran or family.
 - d. Change for indigent veterans TO veteran in financial hardship.
 - e. Change amount is restricted to \$50/month/veteran TO \$250/month/veteran.
 - f. Restrict length of time for veteran receipt of funds to six months.
